There will be an annual fee charged for use of the courts for coaching, during agreed hours. Fee to be negotiated and will be subject to annual review. In return, the coaches will deliver a programme of targeted community tennis activities, including Free Park Tennis and aligned with Adur & Worthing Councils plan - see links for further information:

Your proposed community programme should include a summary of how you will target under-represented groups and those new to the sport. Each venue is a community park site - consider how your community programme would balance the need to provide sufficient casual usage alongside coaching provision. Please include a proposed timetable and annual fee with your plan, along with methodology on evaluating success.

Please complete the attached Expression of Interest form with a covering letter, taking note of the Council's plan. Ensure all required information is included, as per the checklist. The successful coaching provider will be required to uphold the LTA's Minimum Safeguarding Standards as all Adur & Worthing Council park sites are LTA registered venues.
