

Transfer of Ownership Letters of Administration Form

This 'Letters of Administration Form' must be delivered to the Worthing Crematorium, Cemetery Section, Horsham Road, Findon, Worthing, West Sussex BN14 0RG

This form must be completed in **BLOCK CAPITALS** in ink and be fully and accurately stated.

Guidance notes for completing the Transfer of Ownership Form using a Letter of Administration

Where there is an estate of value (typically exceeding £10,000) but there is no Last Will and Testament of the deceased then the 'Rules of Intestacy' applies.

Following this process the Court will issue a 'Letter of Administration'. This vests in the Administrator the Administration of the deceased's estate.

Either the original 'Letters of Administration' or a copy bearing the impressed seal of the Court must be provided to the Cemeteries Service for the transfer of ownership to complete.

It may be that the person requesting to administer the estate is also the rightful owner of the Exclusive Right of Burial and if this is the case then only the completion of this form is necessary for the transfer of ownership to complete.

The Administrator is responsible for the transfer of the Exclusive Right of Burial to the rightful person(s) (see 'Rules of Intestacy').

The requirement for completion of this form exists to ensure that burial rights are assigned only to the rightful owner(s) and serves to protect both the owners of those rights and the Council. It is a procedure used by burial and crematoria authorities in England in accordance with the Local Authorities' Cemeteries Order 1977.
